WHY CLM IS HERE

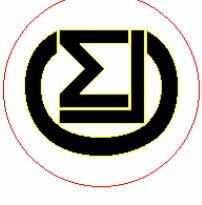

Community Land Management is committed to improving the environment, achieving sustainability of uses of natural resources, and enhancing biodiversity.

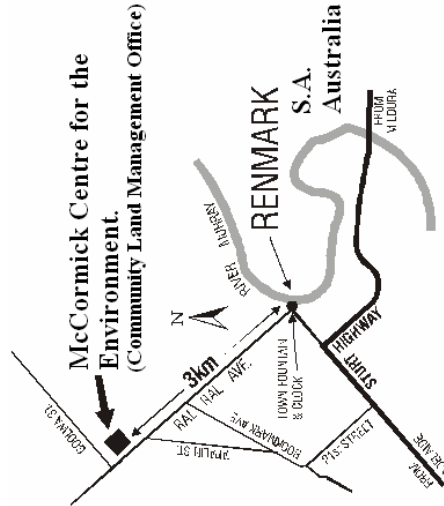
OUR VISION
